Funding to foster innovation and technology commercialization will be made available for qualified Canadian and Chinese participants. Canadian companies may be eligible for up to \$600,000 per project and Chinese firms (registered in Guangdong Province) for up to RMB 1.0 million. The maximum project duration is 3 years.

Canadian Eligibility: 加方申报资格

- Small and medium-sized incorporated and profit oriented companies registered in Canada with 500 or fewer full-time equivalent employees are eligible. 在加拿大注册的中小型盈利性法人公司,全职雇员等同于 500 人以下。
- Companies must be ready to collaborate with Chinese partners on an industrial R&D project.

 Preference will be given to companies that intend to grow and generate profits through the development and commercialization of innovative, technology-driven, new or improved products, services, or processes.

Canadian Funding: 加方资助

Canadian industry may receive up to 50% of their part of eligible project costs through NRC-IRAP funding. 项目评审通过的加拿大企业将获得不超过项目预算50%的加拿大国家研究委员会工业援助计划署的经费支持。
